

**Cabinet Resolution No. (103) of 2025**  
**Regarding the Fees for Services Provided by the Ministry of Sports**

**The Cabinet,**

- Having reviewed the Constitution;
- Federal Law No. (1) of 1972 Regarding the Competences of Ministries and Powers of Ministers, as amended;
- Federal Decree by Law No. (26) of 2019 Regarding Public Finance, as amended;
- Federal Law No. (4) of 2023 Regarding Sports;
- Cabinet Resolution No. (46) of 2024 Regarding the Executive Regulation of Federal Law No. (4) of 2023 Regarding Sports; and
- Upon the proposal of the Minister of Finance and the approval of the Cabinet,

**Hereby resolves as follows:**

**Article (1)**

**Definitions**

For the purposes of implementing the provisions of this Resolution, the following terms and expressions shall have the meanings assigned to each of them, unless the context requires otherwise:

<b>State</b>	:	The United Arab Emirates.
<b>Ministry</b>	:	The Ministry of Sports.
<b>Minister</b>	:	The Minister of Sports.

**Article (2)**

**Service Fees**

The fees indicated for each of the services provided by the Ministry in implementation of the competences prescribed thereto under the legislation in force in the State, and listed in the schedule attached to this Resolution, shall be collected.

### **Article (3)**

#### **Amendment of Fees**

The Cabinet shall have the competence to make any amendments to the fees stipulated in this Resolution, whether by addition, deletion, or modification.

### **Article (4)**

#### **Final Provisions**

1. The fees stipulated in this Resolution shall be collected through the means determined by the Ministry of Finance.
2. The fees for the issuance of approvals stipulated in this Resolution shall become due from the date of submission of the application, while the renewal fees shall become due from the day following the date of approval of the renewal.

### **Article (5)**

#### **Executive Resolutions**

The Minister shall issue the necessary resolutions for the implementation of the provisions of this Resolution.

### **Article (6)**

#### **Repeals**

President's Resolution No. (39) of 2001 Regarding the Adoption of the Organizational Regulation for Private Sports Centers, Clubs, and Offices of Sports Services and Undertakings in the State is hereby repealed, as well as any provision that contradicts or conflicts with the provisions of this Resolution.

## **Article (7)**

### **Publication and Entry into Force**

This Resolution shall be published in the Official Gazette and shall enter into force (30) thirty days from the date of its publication.
